

Executive Summary

Directors' Messages

Dr. Tim Stainton



As I approach my retirement from UBC and the end of my tenure as codirector of the Institute at the end of July 2024, I can't help but reflect back on our journey to date. It is with some nostalgia but mostly a great deal of pride in what we have accomplished in the 13 years since the Institute was established (as the Centre for Inclusion and Citizenship originally). I looked back at one of our first annual reports where we note 'Currently, the Centre has one part-time coordinator and one graduate student assistant'. As you will see from this report, we have come a long way and grown exponentially with a full time coordinator, post doctoral fellows, and a small army of exceptionally talented student research assistants. Our beginnings were rather humble. Laney Bryenton, then Executive Director of the BC Association for Community Living (now Inclusion BC), approached me about joining a

discussion with representatives of the sector about starting a training initiative with a \$100,000 grant from CLBC. It was clear that this amount was not going to establish anything permanent and Laney and her colleagues wondered if there was a possibility of establishing something at UBC. As our discussions progressed it became clear that training was not the only need. Research on issues of concern to people with IDD and their families was virtually non-existent in BC and Canada as a whole lagged well behind the US, the UK and Australia. From these discussion the idea of a permanent entity based at UBC which would address research, training and information sharing, student training and education and, community development emerged and the Centre was born.

I was just finishing up a project reviewing the state of community living in BC for the Provincial government with my colleague from UBC-Okanagan Dr. Rachelle Hole, and it made sense for us to continue to work together on establishing the Centre - it would be the first cross-campus Centre at UBC. In the early days it was, to be frank, very difficult to keep the doors open with no base funding. While we were successful at attracting grants these did not cover the overhead costs of the Centre or allow much scope for our community engagement work, which was a core part of our mission. There were numerous times when we had to seriously contemplate closing the doors and it was only through the commitment of our Coordinator, advisory board and community partners that we managed to stay afloat. That all changed in 2019 when Canadian Institute for Inclusion and Citizenship (CIIC) was established by the Vice Principal - Research and Innovation at the UBC Okanagan Campus in 2019. The stellar advocacy by Co-Director Rachelle Hole and enthusiastic support from UBC-O leadership made the shift to becoming an Institute possible. With long sought after infrastructure funding from UBC-O and the Faculty of Arts at UBC Vancouver, the platform was there to build the robust, internationally recognized entity that we are today.

A big part of our journey has been the wonderful relationships we have established with community, non-profit and Government entities. We work frequently with Inclusion BC, People First of Canada, The Self-Advocacy Leadership Network, Inclusion Canada, numerous local agencies and organizations as well as Government and Quasi Government entities, notably our continued work with Community Living British Columbia. We are grateful for the trust they place in the Institute.

At the heart of any organization is of course the people. Dan Collins as our long standing Advisory board chair and the many people who have served on that group have been central to our success and growth. As our work expanded we brought in a number of research leads for different aspects of our work (see report) all of whom have brought energy, ideas and enthusiasm to keep us growing and committed to our vision. I would be remiss to not mention the small army of research and project assistants that I have had the pleasure of working with over the years. One of the great privileges of being an academic is to help shape the next generation of leaders and I have no doubt about the state of that future based on working and learning with these amazing students.

Two people I need to mention have been central to the success of the Institute and have been my steadfast fellow travellers on this long and at times perilous journey. Cindy Chapman joined us as coordinator early in the life of the Centre, coming to us from Inclusion BC with a wealth of knowledge, experience, connections and most of all a deep understanding of the values and commitments which underpin our work. She often bore the brunt of our early financial struggles but her commitment to our work never wavered and it is to her quiet commitment that we owe much of our success and indeed survival. Working with Cindy has been one of the most rewarding aspects of my tenure. Lastly, I need to acknowledge my incredible co-director Rachelle Hole. We had not worked together until she approached me about partnering on the Community Living Research Project which predated the Centre, I will admit I was somewhat skeptical when I agreed but as sometimes happens in life, a chance encounter can lead to great partnerships. She is a great scholar, advocate, and visionary with a deep and abiding commitment to disability justice. Working with her has been the greatest privilege of my career and I can step away knowing that she will continue to build what we started into something even more amazing and impactful in the years to come. I am also both thrilled and comforted that Dr. Leyton Schnellert will step into the role of Co-Director. Leyton has been one of our most active partners over the years notably leading the theatre project which has produced two amazing shows co-created and preformed by self advocate partners. He brings a wealth of knowledge, connections and more importantly unbridled enthusiasm and commitment to our work. While much has been accomplished since the Centre's inception, the work of realizing full citizenship and inclusion continues. The struggle for justice is not something that ends but rather a constant commitment. I am honoured to have been part of this struggle and believe in a small way the CIIC has, and will continue, to make a difference.

And finally, Tim... You've been a colleague, mentor, and are a great friend. Thank you for welcoming me on this journey with you. You've been generous beyond measure in the ways that you've fostered my career and relationships in the sector. While your role is changing, I know you will not be far away and around for mentorship and advice when we need it. And, I know you can't completely leave the work behind, smile. Thank you!!!!

- Support existing partnerships and facilitate new partnerships to advance knowledge and practice to improve the lives of children, youth and adults with I/DD and their families.
- Build research infrastructure and capacity in Canada in the area of I/DD research.

Learning

- Provide leadership and partnership opportunities for forums, Institutes, conferences, and symposiums aimed at increasing dialogue and knowledge on critical issues to the community living sector.
- Secure research (and other) funding to provide undergraduate, graduate, and post doctoral training and research opportunities (e.g., work study positions, research assistantships, practicums, and participation in community learning events and institutes).

Research Streams

Informed by the principles of disability justice, the Canadian Institute for Inclusion and Citizenship works to inspire and support social change by creating a passion for and commitment to inclusion. We work with people with intellectual and developmental disabilities, families, community, government, and the private sector to promote social justice, equality, and well-being of all citizens.

Our work is structured around the five key research streams below and is guided by and supports the full implementation of the United Nations Convention on the Rights of Persons with Disabilities.

Policy, Practice and Ethics

Primary Lead: Dr. Tim Stainton - School of Social Work, Faculty of Arts, UBC Vancouver

Co-Lead: Dr. Rachelle Hole – School of Social Work, Faculty of Health and Social Development, UBC Okanagan

Individuals with intellectual and developmental disabilities (IDD) face barriers to full inclusion and citizenship. This stream focuses on policy, structures and direct practice that foster and support full inclusion, citizenship, and good lives in the community. This focus includes both provincial and national policy and practice in Canada and internationally. The stream also considers ethical issues and attitudinal barriers that impact full inclusion and citizenship.

Employment and Transitions

Primary Lead: Dr. Rachelle Hole – School of Social Work, Faculty of Health and Social Development, UBC Okanagan

Co-Lead: Dr. Tim Stainton - School of Social Work, Faculty of Arts, UBC Vancouver

Employment is a key aspiration for individuals with intellectual and developmental disabilities (IDD) and a key priority for the community inclusion sector. Research demonstrates that employment enhances quality of life for most working-age adults and is important for social inclusion. This research stream focuses on improving employment for individuals with IDD with an additional focus on transitioning youth as we know intervening early is key to improving employment outcomes for individuals with IDD.

Health and Wellbeing of Individuals with Intellectual and Developmental Disabilities and their Families Across the Life-Course

Primary Lead: Dr. Jennifer Baumbusch – School of Nursing, Faculty of Applied Science, UBC Vancouver

Co-Lead: Dr. Lise Olsen – School of Nursing, Faculty of Health and Social Development, UBC Okanagan

It is well documented that individuals with intellectual and developmental disabilities and their families experience health inequities throughout their lives. This research stream aims to highlight social, political and structural factors that contribute to these inequities. This research will help to inform ethical and equitable policies and practices that support health and wellbeing in each stage of life.

Inclusive Education

Primary Lead: Dr. Leyton Schnellert - Faculty of Education, UBC Vancouver

Co-Lead: Dr. Carly Christensen – Faculty of Education, UBC Vancouver

While research demonstrates the importance and value of inclusive education for all learners, this is not the experience for many children, youth, and adults with intellectual and developmental disabilities. The challenge of developing inclusive schools and providing inclusive experiences extends well past policy to education professionals, families, caregivers and students. This stream is deeply committed to improving inclusive education by using intersectional approaches that consider differences in ability, culture, gender, sexual orientation, race, class, and spiritual beliefs.

Working with Indigenous Communities

Co-Lead: Sue Sterling-Bur, PhD Candidate – Vice President Students, Nicola Valley Institute of Technology

Co-Lead: Dr. Rheanna Robinson, – Faculty of Indigenous Studies, Social Sciences and Humanities, First Nations Studies, University of Northern BC

Indigenous peoples have much to teach when it comes to conceptualizing effective and meaningful practices of equity, diversity, and inclusion. Through respectful, reciprocal, relevant, and responsible relationship building, this stream will mobilize how Indigenous knowledge, traditions, and teachings have the potential to broaden contemporary understandings of inclusion in Canada and around the world.

Highlighted Projects

Toolbox of children's books to promote disability representation



This project is developing resources to assist teachers in engaging in disability justice within their classrooms. These resources were created to critically engage with disabled representation in children's books. Our research supports inclusive education by enhancing critical literacy around disability in children's literature. An integral part of curricula in primary years are children's books. Children's books are part of the social justice movements in classrooms by offering perspectives that shape student self-conceptions and worldviews. Where children's books do depict disabled characters,

these representations can often perpetuate ableism. Our project aims to fill a crucial resource gap, by creating content that doesn't just include, but celebrates disability within classrooms.

Exploring the Use of Navigators to Advance Access to Federal Programs and Services for People with Disabilities

This project seeks to explore the use of "navigators" to support individuals with intellectual disabilities in identifying and accessing Federal programs and supports such as the Disability Tax Credit and the Registered Disability Saving Plan. Navigators serve as brokers who help individuals or families confront complex systems and provide information about supports and services within and across complex and inaccessible systems. The project involves a literature review, jurisdictional scan, focus groups with people with lived experiences and their supporters; key informant interviews; 3-5 case studies; and a survey of persons with lived experiences and their supporters.

IMPACT 2.0 (Defining Best Practice for Employment Interventions for youth with disabilities)

IMPACT 2.0 aims to address employment rates for youth with developmental disabilities by intervening with youth as they transition from school to work through the implementation and evaluation of youth summer employment interventions/programs with ten agency members of the BC Employment Network. The project proposes to establish evidence-based best practice for employment intervention activities and refine and test the employment best practices over three years.

Evidence to Inform Policy and Practice

Community Living BC Grant (2022 – 2025)

We are pleased to be partnering with CLBC on a three contract, that's focus is to collaboratively respond to identified research needs in the sector. Currently there are three sub-projects being funded by this grant. One focuses on the experiences of parents with disabilities (highlighted below) and best practices for supporting parents with disabilities. A second project is looking at how key players in the sector are responding to the housing crisis in B.C. through housing innovations. It includes a survey and qualitative interviews. A third project underway is conducting a literature review of the research that looks at community inclusion programs and services.

Implementing Physical Activity Program in Communities for Children with Neurodisabilities

KidsAction Coaching (http://kidsaction.ca) is an evidence-informed coaching approach to support children with neurodevelopmental and/or intellectual disabilities (NDID) in BC and other provinces. We are a group of researchers & health care providers who engage in co-design of KidsAction with our partners to support children's physical activity in community settings. As part of the BC portion of the project, KidsAction coaching worked closely with Adaptive Snow Sports Sun Peaks for the 2023/24 ski season to provide coaches and families with resources to support their participation in skiing and snowboarding lessons and encourage children's home-based physical activity practice. New resources for snowboarding and home practice resources were co-designed. Networking sessions with parents were also held to facilitate resource sharing and help families connect. Additional partnership activity included trainings held with the Therapeutic Recreation Program at Saskatchewan Polytechnic and the Boys & Girls Club (BCG), Durham, ON (pictured above).

For her research project, "Using population-level administrative health data to assess the health of youth who have a development disability as they transition to adult health services." Dr. Marquis explored a range of health and healthcare service topics that are common during the transition from pediatric to adult healthcare for people with intellectual and developmental disabilities.

During this post-doctoral fellowship, Dr. Marquis has published eight peer-reviewed journal publications. With colleagues, one was an important systematic review of the literature about sibling programs (Marquis, O'Leary et al., 2023). She also published a discussion paper about health inequities (Marquis, Marquis et al., 2024 early review) and was first author on the first ever chapter on caring for people with disabilities in the highly regarded nursing ethics textbook Moral Horizons (Marquis & Baumbusch, 2024).

In February 2024, Dr. Marquis and Dr. Baumbusch presented a webinar, "Transitioning from pediatric to adult healthcare services: Understanding the personal and population-level experiences of youth with intellectual disabilities" for the UBC School of Nursing Rounds. 


